

**ORDINANCE NO. 538**

AN ORDINANCE OF THE VILLAGE OF POTTER, NEBRASKA, TO REPEAL SECTION 31.05 OF THE VILLAGE OF POTTER MUNICIPAL CODE PERTAINING TO THE CEMETERY BOARD; TO REPEAL SECTION 31.06, SECTION 36.02, AND SECTION 36.03 OF THE VILLAGE OF POTTER MUNICIPAL CODE PERTAINING TO THE POLICE DEPARTMENT; TO REPEAL SECTION 31.15, SECTION 36.16, SECTION 36.17, SECTION 36.18, SECTION 36.19, SECTION 36.20, SECTION 36.21, SECTION 36.22, SECTION 36.23, SECTION 36.24, SECTION 36.25, AND SECTION 36.26 OF THE VILLAGE OF POTTER MUNICIPAL CODE PERTAINING TO THE FIRE DEPARTMENT; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND THE BOARD OF TRUSTEES OF THE VILLAGE OF POTTER, NEBRASKA:

Section 15. That §36.25 of the Municipal Code of the Village of Potter, Nebraska is hereby repealed.


Section 16. That §36.26 of the Municipal Code of the Village of Potter, Nebraska is hereby repealed.
